

Parish and Town Council Members' Registers of Interests

Under the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 and the North Devon Council's Code of Conduct, Councillors are required to declare interests that they, their spouse or civil partner or a person with whom they live as a spouse or civil partner, hold. The list below shows the interests currently declared in the following categories:-

Employment

1. Every employment job trade business or vocation for which benefit or gain is received.

Sponsorship

2. Any person or body who has made any payment in respect of election or other expenses incurred in carrying out duties as a District Councillor and any payment or financial benefit received from a trade union.

Securities

3. Any beneficial interest in securities of a body where (a) that body to your knowledge has a place of business or land in the area of the Council; and (b) either: (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the Member has a beneficial interest exceeds one hundredth of the total issued share capital of that class

Contracts with the Council

4. Any current, existing contracts for goods, works or services between the Council and you or any body, firm or company by which you are employed or which you own or in which you have a beneficial interest as referred to in 3 above.

Landholdings and Licences

5. Address and other description sufficient to identify the location of any land or property in the area of the Council in which you have a beneficial interest, indicating whether you are the owner, lessee or tenant, including land in which you may have a licence, alone or with others, to occupy for a period of one month or longer, incusing the land and house you live in.

Land Leased from the Council

6. Address and other description sufficient to identify the location of any land leased or licensed from the District Council by you or any body, firm or company by which you are employed or which you own or in which you have a beneficial interest as referred to in 3 above.

Membership of Other Bodies

7. Any membership, or any position of general control or management of any of the following:-

- (i) Any body or Organisation to which you have been appointed by the District Council as its representative,
- (ii) Any other body exercising functions of a public nature,
- (iii) Any body directed to charitable purposes, and
- (iv) Any body whose principle purpose is to influence public opinion or policy or which in your view might create a conflict of interest in carrying out your duties as a Councillor.
