Proposal: Reserved matters application for erection of one building to provide 5 industrial units (Use Classes B1, B2 & B8). (Outline planning permission 60780 – change of use from agricultural to employment land.)
Location: Plot H (Phase 4), Pathfields Business Park, South Molton, EX36 3DW
